#### TWNA: Leading Cause of Friendship in the Third Ward!

Eau Claire's Third Ward, is an excellent place to live, and the TWNA works to keep it that way. We do that by communicating, collaborating, fundraising, meeting, and informing ourselves about actions, and events, that affect our community.

In 2020, the TWNA initially responded to the pandemic by canceling our April meeting. We then moved outdoors, with social distancing. As winter closed in on us, the TWNA utilized Zoom meetings, and continued to work on our mission. We have continued to meet using Zoom, but in August the TWNA will begin meeting in person, in the brand new UWEC Welcome Center. Thank you to Jake Wrasse, UWEC, Legislative and Community Relations Liaison, and UWEC for your kind hospitality!

The TWNA weighed in on Airbnb issues, and a proposed infill this past year. We were successful in advocating against an infill, but failed to stop the Airbnb, despite hiring an attorney. The TWNA hosted, and helped

launch, the Eau Claire Neighborhoods Association. The ECNA will help us coordinate with other neighborhoods, on issues that affect the entire Eau Claire community.

There are definitely challenges facing our neighborhood, in our near future. ACT 67 makes local control of zoning, more difficult. Opposition to "conditional use permits" is much harder because of this law. Additionally, there are those advocating for doing away with zoning altogether.

The recently completed Chippewa Valley Housing Recommendations document, which is supported by City Staff, speaks about overcoming objections from residents, and increasing density. It discusses the need to get around current zoning laws. The TWNA realizes the importance of local control, and will continue to advocate for it.

Please join us, make a new friendship, and help us protect our neighborhood.

Putnam Park is home to 400 species of plants, 100 species of birds in summer, and 23 mammal species. In 2019 Friends of Putnam Park formed. Their

#### **Neighborly Notes**

#### **Historic District Designation**

Architectural diversity, unique old homes and established landscapes are one of the attractions of living in the Third Ward. Parts of the Third Ward have been designated a historic district and specific homes with in the Third Ward are historic properties. But what does that mean if you own or want to own a historic home?

There are 3 levels of historic designation: national, state and local recognition.

- The National Register of Historic Places is part of the National Park Service program to coordinate and support public and private efforts that identify, evaluate, and protect America's historic and archeological resources.
- The State of Wisconsin administers a registry of historically significant areas called Historic Districts and identifies homes that contribute to the historic nature of the District. The state offers tax credits (25% of total costs!) for renovations if they align with the historic nature of a property. - On the local level the City of Eau Claire has loan programs to assist with renovations of properties in historic areas to encourage purchasing and preserving these properties. Additionally you get to live in a house that is aesthetically pleasing with unmatched architecture. The City encourages sensitive development within a historic district while discouraging unsympathetic changes to occur. https://www.eauclairewi.gov/government/our-divisions/planning/historic-preservation

Several misconceptions surround historic properties. People believe that making changes to these homes is impossible. However interior changes can be done as desired...tasteful updates and technologies often improve historic homes while preserving the interior details that give it character. Changes to the exterior need to be approved by the City Landmarks Commission to assure it retains the architectural style of the home. Commission members include realtors, architects and developers who can offer FREE suggestions for your project. While a historic designation does not protect a home from being demolished, it does improve its chances of surviving.

#### Chippewa Valley Task Force: A Threat to Neighborhoods?

In 2018 the City of Eau Claire assembled 66 regional planners, administrators, relators, financiers, businesses, educators, elected officials, and employers to address the housing situation in the Chippewa Valley. No neighborhood associations were included. Their goal: to better understand housing market conditions, identify factors constraining housing affordability, and investigate potential solutions to supply and affordability. As stated in their summary document: 'Fair & equitable access to safe, quality, and stable housing for all individuals &families is critical for success in health, economic stability, education, & social mobility. www.eauclairewi.gov/home/showpublisheddocument/30413/637102926039270000

Sounds good. So far. Right?

But summary recommendations and actions taken by the City may actually be threats to home ownership and to existing neighborhoods. Much of the document recommends revising zoning, increasing density, relaxing rules on set-backs, lot sizes, allowable uses, relax automobile parking, and increasing infill and redevelopment in existing neighborhoods and corridors, The document outlines city policies, funding, public-private partnerships and civic strategies that the City is considering.

Scott Allen, City Planner and architect of the Housing Task Force recently spoke at a TWNA meeting. He reassured listeners that the Task Force documents were just the initial stages. But if you have driven around Eau Claire and Altoona recently, it's clear that a building boom of MULTIPLE large apartment complexes is underway. Housing Task Force documents repeatedly state AFFORDABLE HOUSING as their goal and particularly, low income housing.

So we have some questions. Has the City achieved its goal of affordable housing through this plan? Do rental development projects meet that need? Have housing prices dropped? Are rental costs decreasing? What are the benchmarks for achieving affordable housing?

One does not build wealth by paying rent. But owning a home can do just that. Home ownership is the surest way to stabilize and improve neighborhoods. It builds communities and fires up the economy in ways renting does not---homeowners buy dishwashers, lawn mowers, fencing, they remodel kitchens and replace roofs.

If you believe home ownership builds communities, we encourage you to get involved. Let the City know you'd like money spent on programs that revitalize neighborhoods and ask them to make home ownership a priority.

#### **City Updates**

Hello Third Ward neighbors! Here are some quick updates for you to stay connected to City of Eau Claire happenings:

Dr. Roderick Jones is the newest member of the Eau Claire City Council, appointed in June to fill the remainder of an at-large seat vacated by Mai Xiong in April. The Spring Election for all five at-large seats on the City Council will be held April 5, 2022, with the filing deadline for candidates on January 4, 2022. Engineering Director Dave Solberg has been serving as the Interim City Manager for almost a year, following the retirement of Dale Peters in October 2020. The city council will restart our city manager search later this summer with the hopes of hiring by the end of 2021, and having the city manager begin their duties in early 2022. I've learned about mask mandates, changes to the landfill, and borrowing money to build a new highway department building. Meetings are tedious and sometimes contentious, but that's how democracy works.

Which brings me to your part in county government. Beyond voting, (which I surely hope you do!) please consider the following:
